

Note: The number of protected trademarks exceeds the number of registered trademarks, since (1) the statistics on international trademarks maintained is conducted since 2011; (2) in the early years of the Madrid system in Kazakhstan, the examination of the claimed designations was not carried out, therefore a certain proportion of international trademarks were automatically granted legal protection.



property (under the national procedure)














## ELECTRONIC FEED BALANCE FROM THE TOTAL VOLUME (2017)




#### NATIONAL APPLICATIONS BY REGIONS (ALL OBJECTS)



## NATIONAL APPLICATION BYREGIONS










#### FOREIGN APPLICATIONS FOR UTILITY MODELS



### DYNAMICS ON ISSUING DOCUMENTS OF TITLE (and registration of treaties)






## DYNAMICS OF RENDERING OTHER SERVICES (not state)

Provision of trademark protection under the Madrid procedure






